NO CONFIDENCE MOTION AGAINST VICE-PRESIDENT

[01] To consider the 'No confidence motion' against the Vice-President, Secunderabad Cantonment Board submitted by the Elected members to the President Cantonment Board, Secunderabad on **1st February, 2016**, requesting him to convene a special board meeting for the same.

The relevant papers are placed on the table.

Resolution: The president welcomed all the members and informed that the Special Board meeting has been convened on the request of 5 elected members viz. Shri J. Rama Krishna, Shri K. Pandu Rangam Yadav, Shri J. Lokanadham, Smt. B. Anitha and Kum. P. Nalini Kiran for moving a no confidence motion against Shri Sada Keshavareddy, Vice-President. The PCB further asked the members to express their views and decisions on the said motion. Shri J. Lokanadham, Elected member, Ward no.8 submitted on behalf of signatories to no confidence motion that due to the ongoing GHMC elections and political pressure, they are withdrawing the no confidence motion. The motion was thus withdrawn. However, the President Cantonment Board instructed all the elected members that Cantonment Board being apolitical organization, the political overtones should not influence the Board functioning and will not be acceptable. Finally, he asked everyone to work together for the well being and development of the Cantonment.
